Environmental Sustainability



Morris Packaging is proud to announce the many initiatives we completed in 2022 to advance our environmental performance in alignment with the Sustainable Development Goals 12 - Responsible Consumption and Production and 9 - Industry, Innovation, and Infrastructure. Our focus on sustainability is embedded throughout the organization, internally for our operations, and externally through educating our customers. Some key highlights from 2022 include:

e-Shipping Partnership for Transportation Logistics

Our commitment to sustainable practices is exemplified by the partnership we finalized with e-Shipping, which provided a streamlined approach to logistics. This initiative not only optimized our shipping tactics but also provided invaluable analytical data. By consolidating loads, we significantly reduce the number of shipments, contributing to a substantial decrease in our carbon footprint.

Production Improvements for Efficiency + Waste Reduction

In our ongoing goals of operational excellence, we implemented production improvements that enhance efficiency while minimizing waste and rejected materials. This concerted effort aligns with our commitment to sustainability but also contributes to a more resource-conscious and environmentally friendly manufacturing process. Morris Packaging is proud of our ability to capture post-industrial recyclable (PIR) materials that we reuse in production instead of being sent to the landfill. In 2022 we were able to recycle over 7,100,000 pounds of PIR material and 105,000,000 water bottles of PCR into our products.

System Optimization for Size Uniformity

In our production facility, we have gone through a system optimization for size uniformity. With this, we revolutionized our production systems to operate with like sizes, fostering increased efficiencies and a reduction in waste. This strategic move enhances our manufacturing processes by shortening our lead times and cost benefits, and it also underscores our dedication to sustainable practices by maximizing the resource utilization of our products.

Trim Waste Reduction through Updated Specifications + Procedures

In 2022 we revised and updated our specifications and procedures for trim waste. With this update, we successfully reduced the amount of trim waste generated before the converting process. This innovation has eliminated the need for a pre-trimming step, leading to considerable savings in materials and ancillary costs including electricity and air, while further bolstering our commitment to minimizing environmental impact.

Global Vision Implementation for Quality Assurance

At Morris Packaging we are dedicated to quality assurance. To ensure the highest product quality and prevent waste, we installed Global Vision technology. This system meticulously checks the film against the provided PDF, detecting errors in real-time. This proactive approach helps us avoid running or dispatching defective products, aligning with our commitment to delivering only top-notch, error-free materials.

Strategic Warehouse Acquisition for Reduced Fuel Consumption

In a strategic move to enhance sustainability in our supply chain, we acquired a warehouse in closer proximity to our plant. This not only streamlines our logistics but also significantly reduces fuel consumption associated with transportation. By making our distribution network more efficient.

Morris Packaging's Sustainable Solutions:

As a leading flexible film packaging supplier, Morris Packaging is committed to fostering sustainable practices in line with the United Nations Sustainable Development Goals (SDGs). Our dedication to environmental and social responsibility is evident through our innovative approach and dedication to working with domestic suppliers, which enables us to provide sustainable flexible film solutions to meet the objectives of SDG 12 (Responsible Consumption and Production). The demand for sustainable packaging solutions has been rising and can come with its challenges. In 2022 we had many sustainable offerings, as seen listed below. We also faced challenges while we navigated these innovative technology solutions to create recyclable structures that could perform efficiently with our customer's filling equipment and pass transportation and drop test



requirements. Through numerous material and equipment modifications, we were able to pass the needed requirements; not only for our customer's manufacturing, but for distribution and retail.

How2Recycle®

Our commitment to transparency and sustainability can be seen with our various structures that have been prequalified as Store Drop-off recyclable by How2Recycle®. Note that additional components, product applications, or other attributes may change the final recyclability of the package. By partnering with How2Recycle® and offering Store Drop-off recycle-ready bags, we can ensure that our products align with recognized industry standards, and meet customer's demands for recyclable packaging solutions.

Polyethylene Terephthalate (PET)/ Polyethylene (PE) Structures

We offer PET/PE structures with up to 45% recycled content, suitable for rollstock, standup resealable pouches, flat bottom bags, and quad bags. These solutions incur only a minimal cost increase compared to our PET/PE virgin material structures, promoting cost-effective sustainable alternatives.

Recyclable PE Material

Morris Packaging proudly presents Recyclable PE material for rollstock, stand up resealable pouches, flat bottom bags, and quad bags, available in gloss, soft matte, and matte finishes. This material option incurs a minimum cost increase over standard PET/PE structures, emphasizing our commitment to affordability in sustainable packaging. Our Recyclable PE material can include up to 20% recycled content in the sealant web in specific applications.

Barrier Structures + Material Efficiency

Our superior barrier structures contribute to a longer sustainable product life while utilizing less material to maintain package integrity. This not only enhances the shelf life of products but also minimizes environmental impact through efficient resource utilization.

Post-Consumer Recycled Plastics + Compostable Materials

Our offerings include post-consumer recycled plastics for rollstock, stand up resealable pouches, flat bottom bags, and quad bags. Additionally, we provide compostable materials suitable for packages up to 2 lb in weight for rollstock or stand up pouches. This diversification supports responsible production and consumption practices.

Zippers

The recloseable zipper component of our packaging solutions are made of PE material and have been pre-qualified as Store Drop-off recyclable by How2Recycle®. This underlines our commitment to ensuring that our products are easily recyclable and align with recognized industry standards.

Customer Support + Technical Expertise

At Morris Packaging, we understand the importance of supporting our customers in achieving their sustainability goals. Our dedicated team offers technical expertise to optimize packaging sizes, promote our recyclable, compostable, and recycled content solutions, and ensure compliance with applicable laws by working with domestic suppliers. Through these processes, we are able to reduce excess material usage, advance our sustainable solutions and reduce our impact on the environment and communities in which we do business.

Diversity, Equity, and Inclusion:

Morris Packaging is deeply committed to fostering a diverse, equitable, and inclusive workplace. Our workforce is diverse, certified by the National Minority Supplier Business Council as a minority business enterprise (MBE). Morris Packaging was also one of the top 10 minority business employers in Illinois and the largest minority owned business in our core sectors of Packaging and Food Ingredient Distribution.

We actively promote diversity through various initiatives such as sponsoring charity events, partnering with local educational institutions, including an apprentice program in Jefferson City, and collaborating with the local correction center for second chance employment. In addition, we are a member of Jobs for Humanity, connecting employers with candidates facing challenges in finding employment.

We uphold a standard of anti-bias hiring practices, leveraging an internal Applicant Tracking System (ATS) and utilizing diverse job boards and social media platforms for recruitment in addition to our second chance hiring opportunities. Our inclusive approach includes communication efforts, surveys, and membership in Jobs for Humanity, ensuring that every individual has a voice and opportunities for employment.



Quality Education

Morris Packaging understands the importance of quality education as a foundation for achieving Sustainable Development Goal 4. We directly sponsor funds for higher education annually, offer new hire mentor programs, and provide ongoing job-specific training and company paid professional development opportunities including relevant memberships, seminars, networking, and training opportunities. Our commitment to education is exemplified through the Morris Family Multicultural Student Center at Kansas State University, promoting an all-inclusive learning experience.

Decent Work + Employee Wellbeing

Morris Packaging prioritizes creating a safe working environment with state-of-the-art engineering controls, comprehensive safety training, and a commitment to "Everyone Home Safe Every Day." We offer a year-round climate-controlled environment, provide work uniforms, and implement health and safety protocols aligned with CDC guidelines.

In 2022 Morris Packaging revamped our current electrical safety program to be compliant with all national electrical safety codes and provided required training for all authorized maintenance personnel. This initiative aims to establish a safe and secure working environment, ensuring not only the safety of our electricians but all employees across the organization. Additionally, we installed a self-retracting lifeline system to the warehouse racking in Jefferson City, MO. So, in the event maintenance is required to enter the racking system Morris Packaging maintenance personnel can work from overhead heights without the risk of falling

Due to the challenges to the workforce during the COVID-19 pandemic, we have increased our benchmarking and assessment of employee benefits to ensure staff retention and recruitment. Every year since, we engage in initiatives that provide us with data for benchmarking our wages, exemplified by our involvement in the Manufacturing Compensation and Benefit Benchmarking Study conducted by Barnes Denning, USI, AMIP, and Northside Bank and Trust Company. Collaborating with our broker, we undertake an annual benchmarking of our benefits during the pre-open enrollment process.



This involves a thorough comparison against industry benchmarks to ensure the alignment of our provider networks, premiums, and employer contributions with those of similarly sized companies in the same sector.

In addition, Morris Packaging administers annual surveys to our employees to ensure we continuously build a positive work culture and environment. We offer this survey anonymously to our employees to garner participation and honest, critical feedback and data to continuously set positive objectives for annual improvement. In 2022 we found through our annual survey that our employees requested improved communication. We utilized this information to respond to their needs by investing in electronic communication boards. We have regular training programs that provide learning opportunities in conjunction with career paths. Our key measures of success are reductions in turnover and increased internal promotion rates.






FUTURE GOALS FOR 2023

In 2023 we plan to calculate our Scope 1 and Scope 2 greenhouse gas (GHG) emissions. Calculating greenhouse gas emissions is essential for us to understand and minimize our environmental impact. We will establish our baseline emissions for scopes 1 & 2 which will allow us to benchmark our current operations to then create reduction and sustainability strategies to lower our impact. The process of measuring our scope 1 emissions includes measuring all direct emissions from activities within our control, including fuel consumption on site and with our fleet vehicles. Our scope 2 measurement includes our indirect emissions from electricity and gas purchased.
